

**“Moments by the Harbour @Harbour City”  
Promotion Terms & Conditions**

1. Promotion period is from 30 Sep 2024 to 17 Nov 2024.
2. Participants are required to register online via [pass.harbourcity.com.hk](http://pass.harbourcity.com.hk) as HARBOUR CITYZEN Member (Member) to join this promotion. Each participant can register as Member ONCE only; Harbour City Estates Limited reserves the right to request Member to present their proof of identity for verification.
3. During the promotion period, Members are required to acquire the “Scenic Guide” at the mall’s map directories, concierge counters or Shoppers' Care Centres, follow the instructions and collect stamps from three signature outdoor sites at Harbour City – 2/F Balcony, Gateway Arcade, 4/F Terrace, Ocean Centre and Ocean Terminal Deck.
4. At the same time, Members are required to take one photo with Bunmiebun at the limited-time check-in spot located at Canton Road Entrance of Gateway Arcade (near Shop G101 Giorgio Armani); and take one photo with the harbour view at one of the signature outdoor sites (the participant’s front face must appear on both photos). The two photos must be shared on Facebook, Instagram or Xiaohongshu with designated hashtags (upon completion, collectively referred as “qualified photos”) in order for Member to redeem rewards at the redemption counter.
